# New Positions ... Familiar Faces



Supervisor Ron Johnson

St. Charles Township elected a new Supervisor and Trustee in April, 2017. They don't really need any introductions, however, they are very familiar faces to our township.

Ron Johnson, retired Highway Commissioner, was elected Supervisor, and Jerry Swanson, retired Supervisor was elected as a Trustee.

Ron first came to

St. Charles Township Road District in 1983. He was appointed Foreman and held that position until 1997 when he ran for Highway Commissioner and won. In 1999 he was elected Vice President of the Kane County Highway Commissioners' Association and in 2001 elected President. Ron was appointed to the State Highway Commissioner's Board as the Treasurer for two years and eventually became President in 2005. Ron also was on the Township Officials of Illinois (TOI) Board of Trustees for seven years at the same time as Jerry Swanson, Township Supervisor was President of the State Supervisors' Board. As far as we know, this was the first time that a Supervisor and a Highway Commission from the same township served on the TOI Board of Trustees at the same time.

Ron retired in July 2015 after 32 years of service. In 2016 the Supervisor's position became available and Ron decided to give it a try. We are so fortunate to have Ron back with the Township. He is an asset to the board and our community.

Jerry Swanson began his career with St. Charles Township in 1981, as Trustee, a position he held until 1993. He was then elected Township Clerk, succeeding Fred DeMien. In 1995 he was appointed to fill the position of Supervisor, succeeding Bob Henningson who had retired. Jerry held this position until 2012, retiring as Supervisor, but fulfilling his four-year obligation by serving as Trustee until 2013.

During Jerry's 32 years with the Township, he served as President of the Township Officials of Kane County for five years, was a member of the Board of Township Officials of Illinois for eight years and a member of the Board of Township Supervisors of Illinois for 10 years, serving two years as President.

In 2016, Jerry was approached to run once again, choosing to run for Trustee rather than Supervisor. He was honored to be asked and honored to serve, hoping to bring needed experience and oversight to the Town Board. Jerry said he enjoys being involved and looks forward "To being back on board."

The Assessor, Diane Hemmingsen, and Highway Commissioner, Steve Frohling, were appointed to their positions in 2015, ran in their first election this year. Steve was sworn in May 15, and Diane will take her oath at our December board meeting on the 13th.

# St. Charles Family continues to serve the Township

In April of this year, Roger Ronzheimer, the Cemetery Superintendent for the past 42 years, retired. Roger's retirement ended an era of three generations of Ronzheimers who have maintained the Township cemeteries. Congratulations, Roger, we hope you are enjoying your retirement.

But hold on ... Here comes Brooks Ronzheimer to start a fourth generation to run the Township Cemeteries. Brooks was appointed Superintendent in April when his father (Roger) left. Brooks, we wish you many successes.

A new addition at St. Charles Township in Union Cemetery is our "Columbarium." A Columbarium is an above ground burial vault or "niche" as they are called for holding cremains. Each niche holds 2 cremains. Approximately 51% of all burials today are cremations. By using the Columbarium, the Township is able to save precious space in the rest of the cemeteries, as well as being a cost savings for the families. Burials in Columbaria versus a lot burial can be as nice a memorial and is less expensive.

#### Cemetery General Guidelines:

- Cemeteries are open from dawn until dusk.
- The Cemetery Office is open from 7am to 3:30pm Monday through Friday, except on designated Township holidays.
- Shepherds hooks must be removed by November 1 of each year.
- Winter decorations, such as holly, evergreens or artificial wreaths, may be placed on graves beginning November 1 and may remain until the following March 1, after which date all such decoration will be removed as soon as weather permits. If these are to be kept for future use, they must be removed and cared for before March 1.

# A short history of Columbaria

A columbarium (pl. columbaria) is a place for the respectful and usually public storage of cinerary urns (i.e., urns holding a deceased's cremated remains). The term comes from the Latin "columba" (dove) and originally referred to compartmentalized housing for doves and pigeons called a dovecote.

Today's columbaria, besides housing urns instead of pigeons, have changed in many ways. The first columbariums used for cremation urns were built in ancient Asia by Buddhists, whose faith preferred cremation. These buildings were typically very elaborate structures patterned after Buddhist temples of the time.

Modern columbariums take a variety of forms and generally follow elegant-but-simple architectural designs and are part of large, urban cemeteries and – because they can house many people of different religions and give their residents a peaceful, eternal resting place where family and friends can pay their respects.

# St. Charles Township Road District News

#### Greetings from the Township Road District.

I would like for you to know that the Road District receives 1 percent of the 2 percent that the taxpayers pay to the Township for their taxes. With this 1 percent, we provide such services as: resurfacing, road repair, edge of road repair, culvert and drainage work, plowing and salting of the roads, brush trimming and mowing, brush pickup program, signage on the road, truck and equipment repairs and maintenance, and various other jobs on 90 miles of road.

We also provide emergency services when needed, and we are on call 24 hours a day and can be reached through the Sheriff's office if needed after our regular office hours.

Please be sure to call the Road District phone number not the Supervisor's Office if you have flooding problems, signs down, trees down, or any other emergency situation that needs immediate assistance. If the situation arises and you are in need of sand and the bags because of flooding, please call our office and we will get them out right away to you. Remember, we can't help if we don't know you need it, so remember to call the Township Road District 630-584-3496 besides calling Kane County Office of Emergency Management in the future when help is needed in emergency situations. # Homeowner's Association Information

The Township is seeking homeowner's association information for subdivisions that are in our unincorporated area. We want to keep you informed of any road improvements that may be happening in your subdivision, such as blacktopping or road closures.

# **Managing Your Leaves**

- Mulching Leave shredded material on lawn and around trees and shrubs.
- Place shredded material in gardens or in adjacent wooded areas.
- Do not put leaves or grass for mulching in roadway or ditches. They will plug up storm drains especially in subdivisions that have curbs and will cause flooding.
- Composting Produce a valuable soil amendment for garden areas.

Bagged Collection of Leaves & Other Landscape Wastes - Please Note that local garbage companies provide this service to Township residents for a fee.

Suggestions:

- No single approach will easily handle all your leaves. Try mulching as many as you possibly can, composting some, and then maybe bag the rest for your garbage pickup.
- Always shred or chop your leaves. Chopped leaves work best for mulch, compost faster, and fill fewer yard waste bags.



We will make every effort to keep your streets clear and safe for you. We will also have it done for you in a timely manner. But, we can only do that with your cooperation, by not parking your vehicle along the roadways until after they have been plowed and widened. We have been having a problem with parents parking by school bus pickups. Remember, we can't plow if cars are parked on the road. Please be considerate of our plows and move if our trucks are in the vicinity trying to plow the roads. We are doing this for you and the safety of your children.

Remember, if your mailbox is accidentally pushed over during a snowfall by one of the township snowplows only, please call the township and we will correct the situation as soon as possible. In the meantime try to place the mailbox temporarily upright so your mail will get delivered. However, we do not fix mailboxes if they are knocked over by someone backing into them, another vehicle hitting them or possibly a hired snowplow company clearing a drive and pushing the snow into your mailbox. Remember, no one knocks these mailboxes over on purpose, they are just trying to move the snow and most of the time it's the weight of the snow pushed up against an old post that causes the post to break. If the township has to replace a mailbox it will be replaced with a legal mailbox and post as required by the Postal Service not the fancy mailboxes that may have been there before.

#### Also, please be aware of the following:

605 ILCS 5/9-130. Deposit of snow or ice upon public highway—Prohibition

Section 9-130. No person, firm, corporation or institution, public or private, shall plow or remove or cause to be plowed or removed ice or snow from any shopping center, parking lot, commercial or institutional service area or driveway or any other public or private service area or driveway and deposit such ice or snow upon a public highway or along the shoulder or edge of a public highway.

Any person, firm, corporation or institution, public or private, which violates this Section, is guilty of a petty offense.

ALSO, PLEASE REMEMBER: NO PARKING ON ANY TOWNSHIP ROADS UNTIL AFTER ALL SNOW HAS BEEN CLEARED.

# "Brush Only" Burning Regulations

Kane County has a burn ordinance that prohibits the burning of "landscape waste," which means all accumulations of grass cuttings, shrubbery cuttings, leaves, flowers and weeds. Residents may, however, still burn "brush" as long as they follow the Standard Restrictions.

#### **Standard Restrictions:**

- Only on the property where the landscape brush was generated;
- Only on sunny days from 10am to 3pm;
- Not when wind exceeds 10 mph;
- Not within 20 feet of any building, structure or property line;
- Not during announced inversion conditions or ozone alerts

Any burning must be supervised until the fire is extinguished; a fire extinguisher, garden hose or water source must be available at the burning site.

#### **Exemptions:**

- Any property zoned or used for agricultural purposes.
- Burning for prairie restoration or firefighter training.
- Burning of brush for recreational fires, but the fire cannot be larger than 3 ft. x 3 ft. x 3 ft.
- Ceremonial fires for a scheduled public or private event.

  Notice must be given to the local Fire Department, and a permit obtained from the Kane County Health Dept. at 630-208-3801.

#### Penalties:

• Any person who violates any provision shall be punished by a fine not to exceed \$100 for a first offense and a fine of \$500 for subsequent offenses.

#### Junk Cars

If you have a problem with vehicle parking, please call the Sheriff's Office first. If you have a problem with junk cars that are abandoned in your neighborhood, please call the Kane County Health Department at 630-208-3801 because it is a health problem.

No one wants to have this view out their window. Junk cars don't have to be a problem. You can even turn rust into cash. Just Google: *Junk car buyers Chicago*, and a list of options are available to owners.

#### IMPORTANT INFORMATION BEFORE

Digging, Building, Planting in Road Right-of-Way

The road right-of-way is the area usually 33' feet from the center of the road (some roads vary). That area (33' feet from the center of the road) belongs to the Road District. You must get permission from the Highway Commissioner to do anything in that easement area. Boulders, underground fencing and sprinkler systems must be kept out of the road right-of-way. Stay in your property line when installing these things.

Also, MONUMENT MAILBOXES on road right-of-ways are illegal and not safe to the motoring public. Mailboxes must not be bigger than a 4x4 post per Post Office Regulations. When these regulations are not followed properly and things are built or planted in the road right-of-way, it cost the taxpayer because the township is forced to pay legal fees to have these situation remedied. Contact the Road District before putting anything in the easement (right-of-way) in front of your house.

REMEMBER TO CALL J.U.L.I.E. BEFORE YOU DIG UNLESS YOU HAVE A CONTRACTOR DOING THE WORK AND THEN THEY ARE TO CALL IT IN! THE NUMBER TO CALL IS 1-800-892-0123 AND BE SURE TO HAVE THE FOLLOWING INFO READY WHEN YOU CALL:

- Your name, address, and telephone number
- County and city or unincorporated township
- Location of the dig site
- Extent of the work involved (reason for dig)
- Date work will begin
- Permit number (if applicable)
- Section and quarter section numbers (if available)

# Safety Tidbits - Township Roads

- People driving on Burr Road or Crane Road should be aware of the hidden driveways on the top and bottom of hills and around curves. Be aware of the deer that run out in front of the cars and the bicyclists who sometime use the road right-of-way. These roads are very hilly and potentially dangerous to people who travel over the speed limit of 35 mph on Crane Road and 40 mph on Burr Road.
- School Speed Limits and Work Zone Speed Limits should be strictly adhered to – let the kids and road crew come home safe.
- Violations if you have a problem with speeding or parking on your street, please let the first call be to the Sheriff's department at 630-232-6840.
- Reminder: Watch your speed limit! There have been a number of complaints and the Sheriff's office is aware of this. WATCH YOUR SPEED for your safety as well as your neighbors!

- ➤ <u>Current</u> utility bill, lease, or mortgage statement of the person registering, to show proof of residency. <u>Letters from landlords and/or roommates will NOT</u> be accepted.
- > 30 days (1 month) proof of <u>all current household income</u>(paycheck stubs, SSI, SSDI, pension, child support, TANF, unemployment, etc...) of adults 18 years and older living in the household.
- > Birth Certificates of all children in the household, 17yrs & under.
- ➤ Childs sizes in clothing, shoes, & wish list.

**PLEASE NOTE:** To better process your information in a timely manner, we ask that you bring all of the above with you at the time of registration. If you do not have all of the information at the time of registration, we will be unable to process your request. You must be 18 years and older to register.

We encourage you to leave your children at home with an adult, due to the lengthy registration process.
