1. The meeting was called to order by Supervisor Ronald C. Johnson at 7:00 PM.
2. Supervisor Johnson asked Jerry Swanson to lead the Pledge of Allegiance.

4. Supervisor Johnson asked if there were any questions or concerns regarding the minutes of April 9, 2025.

Hearing none, Supervisor Johnson requested a motion to approve the April minutes.

Mary Lynn Swanson made a motion to approve the April 9, 2025, minutes. Jim Flanigan seconded the motion. 5 ayes. 0 nays. Motion carried.
